

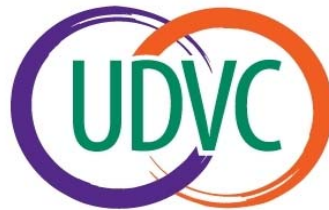

This report provides statistical data demonstrating the prevalence of domestic violence in all communities in Utah. Domestic violence not only affects the victim and the abusive partner, but also children, extended families, friends, co-workers, neighbors, and the larger community.

- **28 domestic violence — related deaths occurred in Utah from July 2010 to June 2011; 7 of 8 judicial districts had at least one domestic violence — related death.**
- **1,953 permanent protective orders and 204 civil stalking injunctions were granted statewide.** Protective order numbers and civil stalking injunction numbers do not include ex parte orders.
- **3,751 domestic violence criminal charges were filed in district courts statewide.** Domestic violence charges are those criminal charges filed in district courts statewide, and do not include the local justice courts. Because many domestic violence cases are filed as Class B Misdemeanors, a significant number are filed in justice courts and are not included in this report.
- **2,224 women, 45 men, and 1,958 children were sheltered in 16 emergency domestic violence shelters in Utah, a total of 4,227 people served.** Domestic violence shelters throughout Utah provide services to individuals from across the state, and occasionally the nation. The number of individuals shown to have accessed services at shelters in your district may include some who resided outside the district. Some domestic violence shelters may also provide services to more than one judicial district.

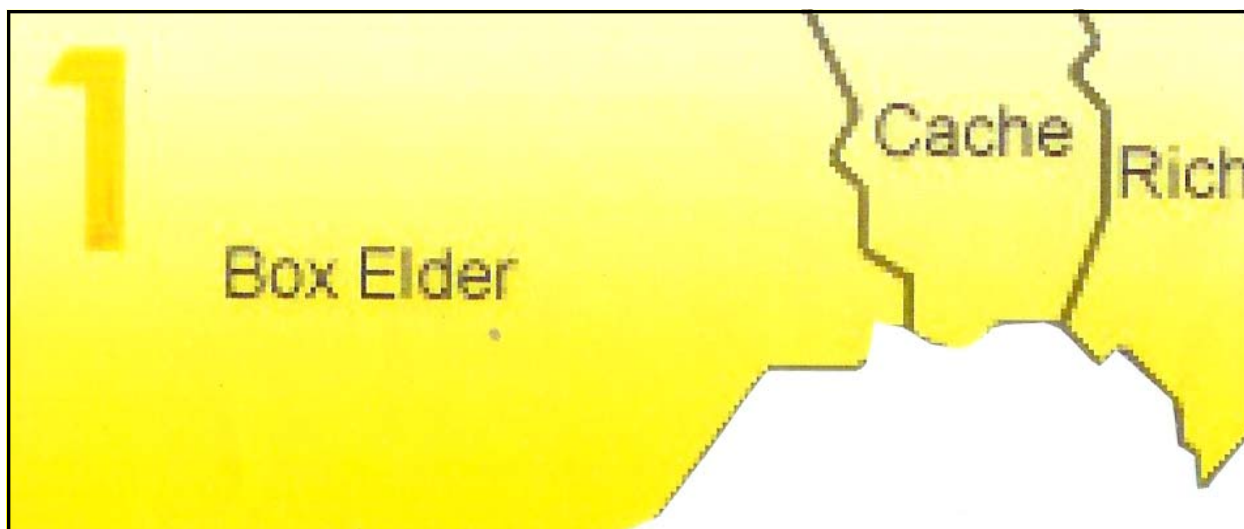
